

Refund and cancellation policy

For the RTI World Meeting 2024, including day-tours:

A full refund is available to any participant who cancels their registration before the 17th of August 2024. A 50% refund will be applicable if cancelled before the 1th of September 2024 and zero refund if cancelled after that time. This refund will be based on the current foreign currency rates on the day and any foreign exchange gains, or losses and related bank charges are for the attendee. Any alterations to an existing booking, including a transfer to another attendee will be allowed at an administration fee of € 20 per person.

Registrations for the RTI World Meeting will officially close on the 16th of August 2024. Should there be any late registrations accepted, then NO REFUNDS of these registrations will be considered. Transfer to another attendee will be allowed at an administration fee of Euro 20 per person.

For any of the official RTI World Meeting 2023 Pre-tours:

A full refund is available to any participant who cancels their registration before the 19st of July 2024. A 50% refund will be applicable if cancelled before the 2th of August 2024 and zero refund if cancelled after that time. This refund will be based on the current foreign currency rates on the day and any foreign exchange gains, or losses and related bank charges are for the attendee. Any alterations to an existing booking, including a transfer to another attendee will be allowed at an administration fee of € 20 per person. Registrations for the RTI World Meeting Pre-Tours will officially close on the 19th of July 2024. Should there be any late registrations accepted, then NO REFUNDS of these registrations will be considered. Transfer to another attendee will be allowed at an administration fee of Euro 20 per person.

VIP Pretour

In deviation with the above, special conditions apply for the VIP pre-tour. Payment will be made in two parts with a deposit of € 1000, for which no refund is possible. The aforementioned rules apply to the remaining amount of €1,024.
